



Terms and Conditions

The terms "ET" "we" and "our" refer to EARTH TRAVELLERS. We are a tour operator registered under the Registry of Joint Stock co. in Nova Scotia which offers and operates all the trips listed herein. Please review the terms and conditions set out below to draw your attention to the fact that our obligations to you are limited.

PRICES, RESERVATIONS AND PAYMENT

ET charges a single supplement to individual travellers who wish to ensure that they have private rooms throughout a trip. Additional charges may apply if additional resources are required. *A minimum 10% deposit of trip value is recommended at time of booking. A waiver form must be checked, initialed and signed prior to the start of the trip, preferably upon completion of final payment.

DEPOSIT

*ET recommends a minimum 10% deposit as soon as possible to secure dates. This is especially important for private groups. This deposit can be refunded according to the table below. I.e., deposit is fully refundable up to 90 days before start of trip.

CANCELLATION POLICY

If you must cancel your reservation, the fees for doing so are as follows:

Number of days prior to your trip:

90+	100% Refund
75-89	75% Refund
60-74	50% Refund
0-59	No Refund

In the event of flight cancellations due to: catastrophic natural disasters, security conditions, health hazards and any other government restrictions there will be a full refund issued.

CANCELLATION BY EARTH TRAVELLERS

ET reserves the right to cancel any trip at any time for any reason determined in our sole discretion, including; if there are too few participants, or if the quality of the trip or the safety of travellers is judged by ET to be compromised. In such a case, refund of payments received by ET shall be fully refunded. In the event of cancellation, ET is not responsible for any loss incurred on account of non-refundable or non-transferable air tickets or other unrecoverable travel costs.

PREPARING FOR YOUR TRIP

Our trips entail risks—and rewards—beyond those encountered at home. We count on our travellers to ensure they are healthy and fit; and to appreciate that living standards, practices, services and accommodations may differ from country to country.

HEALTH

By registering for your trip, you certify that you do not have any physical condition or disability that would create a hazard for you or other travellers and that you have received all appropriate or necessary vaccinations and/or medical advice. Please consult your doctor.

INSURANCE

Before travelling on a trip, we strongly recommend you have travel insurance with a minimum medical, evacuation and repatriation coverage, covering all applicable dates of travel with ET. This insurance must cover personal injury and emergency medical expenses. We strongly recommend you extend your coverage to include cancellation, curtailment, and all other expenses that may arise as a result of loss, damage, injury, delay or inconvenience while traveling. Review your personal insurance and health insurance to ensure you have coverage appropriate to meet your needs, and the needs of your family and dependents, in case of any loss of property or illness, injury or death.

LIMITATION OF LIABILITY, RELEASE AND INDEMNITY
